

At File Name, browse to location that you want to save the digital signature file. You can use this same signature file on each ballot form you create, as well as any other pdf form you want to sign with a digital signature.

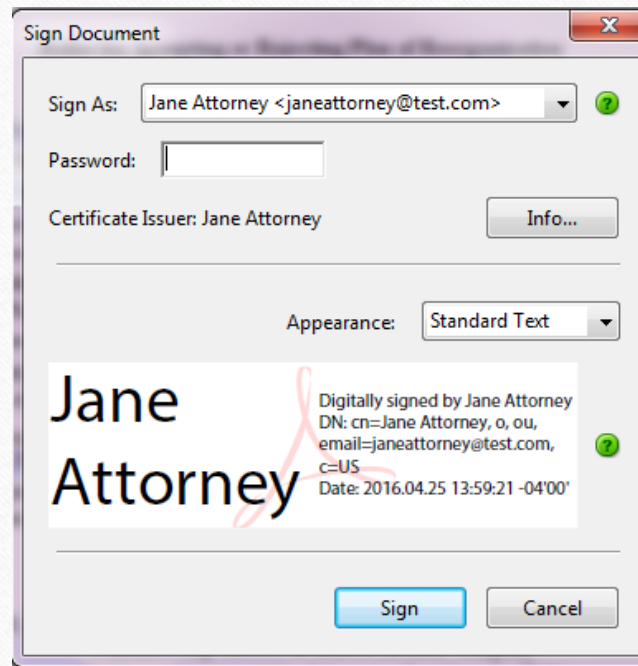
Create Password. Click Finish.

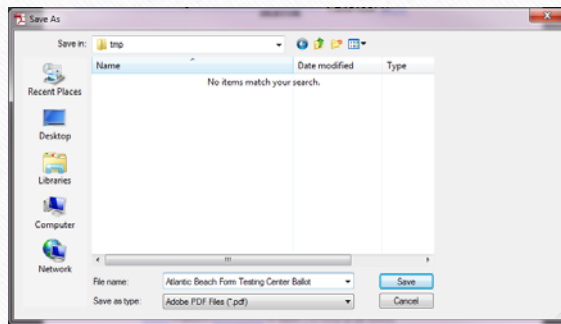
