Local Rules Amendments

A new version of the local rules has been published, effective 12/1/2022. This new version contains the proposed amendments published earlier this year. The new version of the rules can be found by clicking here.

A new version of the administrative guide has been published, effective 12/1/2022. This version contains one change to the service chart. The motion to incur debt now has a 7-day deadline set for recommendations by the trustee regarding motions to incur debt for motor vehicles. All other motions to incur debt will continue to have a 14-day deadline. A new version of the administrative guide can be found by clicking here.

A new version of the local chapter 13 plan has been published, effective 12/1/2022. This version deletes the first sentence of Section 7.2 of the plan, regarding trustee liability. The new version of the form plan can be found by clicking here.

LMM Form Changes

The Judges for the EDNC have approved revisions to Form 01, Form 05 and Form 06 related to the Loan Modification Management (LMM) program. This includes revisions to the court's LMM Procedures. The changes will be effective January 1, 2023 and will apply only to cases in which the motion for LMM is filed on or after that date. The updated forms may be viewed by clicking here.

Reports, Reports and More Reports

We have seen a great deal of errors recently from filers when choosing a docket event for different types of reports in CM/ECF. Here are a few of the common reporting events used in Chapter 11 cases and what they should be used for:

<u>Monthly Report</u> – the report filed each month until confirmation <u>Postconfirmation Report Under</u> 2015 – the monthly report filed in confirmed cases

<u>Quarterly Disbursement Report</u> – filed to report disbursements and the amount of quarterly fees to be paid

<u>SubChapter V Pre-Conference Report</u> – filed in Subchapter V cases only, prior to the status conference

<u>Status Report</u> – filed at the direction of the Judge, typically pursuant to a hearing

QUESTIONS/ANSWERS:

- **Q.** I need to file an amended motion. Do I select the same motion event I selected when filing the original motion?
- **A.** No. When filing an amended motion, you must select the *Amended/Amendment to Motion Application* event and refer the entry back the original motion. Please do not select the same event a second time!
