### QUESTIONS/ANSWERS:

**Q.** I am filing a motion to continue a hearing. Do I need to select a prefix from the drop-down list on the last screen (First, Second, etc.)?

**A.** Yes. Motions to continue hearing, conference or trial should be classified on the docket numerically in order to keep track of how many continuances have been requested with regard to a particular matter. Filers should review the docket to determine how many total continuances were previously requested on behalf of any party in the case. *Please note that this does NOT apply to motions to continue the 341 meeting.*
