#### New Event: Name Changes

Please note that effective October 1, 2022, Debtor name changes will require a motion. A new "Name Change" event will be found under the Motions category. There will be an associated form order for this event, so an order will not need to be uploaded. The form order contains language indicating that the movant will serve all creditors and file a certificate of service evidencing same. Once the motion has been allowed, the debtor's name will be updated on the docket. The name the case was filed under will be added back as an alias.

The "Name Change – Debtor (Text)" option under Miscellaneous will be removed from CM/ECF.

#### **Notice of Death of Debtor**

The court is changing its procedure regarding deceased debtors. In the past, when a Notice of Death of Debtor was filed, the clerk's office added the word "Deceased" after the debtor's name on the docket. We will no longer proceed in this manner, effective immediately. Rather, we will add the words "Estate of" in front of the deceased debtor's name. So, for example, a debtor named John Smith will appear as Estate of John Smith on the docket.

#### Reminder: Local Rule 9022-1

Please let this serve as a reminder that a General Order was entered on May 18, 2022 by the Judges for the Eastern District of North Carolina, adopting Local Rule 9022-1. Upon entry of a PDF order submitted by a party, the submitting party must serve a copy of the order on required parties and file a certificate of service evidencing same within 3 days.

#### **Proposed Amendments**

The Judicial Conference Committee on Rules of Practice and Procedure has approved for publication for public comment the following proposed amendments to existing rules and forms, as well as one new rule:

- Appellate Rules 32, 35, 40, and Appendix on Length Limits
- Bankruptcy Restyled Rules Parts VII to IX, Rules 1007, 4004, 5009, 7001, 9006, and proposed new Rule 8023.1
- Official Bankruptcy Form 410A
- Civil Rule 12
- Evidence Rules 611, 613, 801, 804, and 1006

The public comment period opens on August 15, 2022, and closes on February 16, 2023.
