QUESTIONS/ANSWERS:

Q. I have to file a motion to continue the hearing on my objection to the Chapter 13 Plan in a case. Do I use the "Continue Hearing" event under Motions?

A. No. There is an event specific to confirmation hearings in Chapter 13 cases. It is listed as "Continue Confirmation Hearing (Ch 13)" under Motions. The "Continue Hearing" event should be used to continue all other hearings, including confirmations in Chapter 11 cases.

Note: If you are continuing BOTH a confirmation hearing AND another matter in the same motion, you must select both events.
