## **Debtor Audits**

Effective March 13, 2023, the Bankruptcy Administrator will resume its designation of individual Chapter 7 and Chapter 13 cases for audit. These audits were suspended in March 2020 due to public health concerns associated with the COVID-19 pandemic. The Bankruptcy Administrator Program's resumption of debtor audits is made in conjunction with the U.S. Trustee Program. Questions regarding these debtor audits may be directed to the Bankruptcy Administrator.
