Local Rules Committee

Reduced Response Time/Expedited Hearing

When filing a motion to both reduce response time and expedite hearing, the court's procedure is as follows:

1. The motion should be filed without a notice included.
2. A proposed order allowing the motion should be uploaded with the correct response deadline and hearing information.
3. Once the signed order has been entered, a Notice of Hearing and Certificate of Service should be filed, which includes the date, time, and place of the hearing. *(Note: This should be filed using the Notice of Hearing event under Miscellaneous, NOT the Notice of Motion event.)* When docketing, the drop-down box containing the hearing information should be selected.

Loan Modification Management

Please be advised that the LMM order approving final loan modification has been revised and the updated version has been posted to the local forms section on the court's website. Going forward, the updated order should be submitted to the court. The order may be viewed by clicking [here](#).

Request for Comments

The Judicial Conference Committee on Rules of Practice and Procedure has approved publication for public comment of the following proposed amendments to existing rules and forms, as well as one new rule.
