QUESTIONS/ANSWERS:

Q. I am filing a Notice of Appearance in a case on behalf of the following creditor. Is it necessary for me to enter the full name when adding the creditor to the case?

U.S. Bank National Association, not in its individual capacity, but solely as Trustee for RMTP Trust, Series 2021 BKM-TT

A. No. The court prefers that the creditor be entered into the database without servicers, successors, trustees, etc. Also, using all CAPS should be avoided and quotation marks should be omitted. These create issues with the online Proof of Claim feature. In this case, entering the creditor as U.S. Bank National Association is sufficient.
