### **Amended Chapter 13 Plans**

*Please be advised that any Amended Chapter 13 Plan that has **not** gone to hearing must be served on all creditors. If the plan has gone to hearing, and amendments are announced under the Resolution Protocol, and those amendments either increase the base to the trustee or affect 1 or 2 creditors, only the trustee and those limited affected creditors are served with the amended plan filed after the hearing. In all other cases, the amendment to a plan not under the Resolution Protocol must be served on all creditors (i.e., the process starts all over again).*

### **Telephone Conferences**

*You may have realized that your most recent Notices of Telephone Conference are a bit different these days. Effective November 30<sup>th</sup> the court will no longer be using our familiar AT&T Telephone Conference numbers and will begin to use ZOOM Audio to conduct all telephone conferences.*

### **Automatic Dismissal Under 521(i)**

*If an accelerated petition is filed, and schedules and statements will not be filed by the 14-day deadline set out in the deficiency notice, a Motion to Extend Time to File Schedules should be filed. Failure to request an extension may result in a show cause hearing being scheduled.*
