E-Filing Tips

Requests re: Debtor Electronic Notice (DeBN): In a joint case, please do not combine these into one PDF document. A separate docket entry should be made for each debtor.

Amended Schedules: When an Amended Summary of Schedules is included with amended schedules in a PDF document, the Summary of Schedules event must be selected when filing. If a Declaration by Debtor is included in the PDF, you do not need to select the Declaration by Debtor(s) event.
