<b>Use</b>	Use this form to order transcript of proceeding. Complete a separate order form for each case number for which transcript is ordered.
<b>Completion</b>	Complete Items 1-15. Do not complete shaded areas which are reserved for the court's use
<b>Order Copy</b>	Keep a copy for your records.
<b>Submitting to the Court</b>	Mail, fax, e-mail, or upload via docket entry in CM/ECF (Request for Transcript of Hearing/Trial).
<b>Deliver Time</b>	Delivery time is computed by the transcription company from the date of receipt of the order.
<b>Completion of Order</b>	The transcription company will notify you when the transcript is completed.
<b>Balance Due</b>	If the deposit fee was insufficient to cover all charges, the transcription company will notify you of the balance due which must be paid prior to receiving the completed order.

<b>Items 1-14</b>	These items should always be completed.																
<b>Item 6</b>	Only one case number may be listed per order.																
<b>Item 11</b>	Place an "X" in each box that applies.																
<b>Item 12</b>	Place an "X" in the box for portion requested. List specific date(s) of the proceeding for which transcript is requested. Be sure that the description is clearly written to facilitate processing.
