TO: ALL CREDITORS AND PARTIES IN INTEREST:

NOTICE IS HEREBY GIVEN that provided no objections by a party in interest are filed with this Court on or before **February 7, 2019** (the "Response/Objection Deadline"), upon approval of the United States Bankruptcy Court for the Eastern District of North Carolina (the "Court" or the "Bankruptcy Court"), the property described herein shall be sold via auction and public sale in the means and methods described herein.

FORWARD AND INTRODUCTION

This Notice is given for the purpose of providing all creditors and parties-in-interest with information reasonably calculated to allow for an informed decision as to whether to support, object or abstain with respect to this Notice of Proposed Public Sale and Commissions to Auctioneer (the "Notice").

The real property to be sold includes three (3) tracts of real property in Cumberland County, North Carolina, owned by the Debtor, which are more specifically identified on the attached Exhibit A (collectively, the "Property"). The public sales will be held on March 20, 2019, at 10:00 am for both of the Doc Bennett Road Properties, and at 12:00 pm for 8448 King Road, on site at each Property address identified on Exhibit A (the "Proposed Sale").

COMMISSIONS TO AUCTIONEER

An Application for Employment and Compensation of Auctioneer (D.E. 186; the "Application"), seeking the employment of Country Boys Auction & Realty Co., Inc., as the Auctioneer for the Chapter 11 Debtor, was filed with the Court on November 29, 2018, and was approved by Order entered December 27, 2018 (D.E. 197; the "Order Employing Auctioneer"). Pursuant to the Order Employing Auctioneer, Local Bankruptcy Rule 6005-1(a), and the Chapter 11

Administrative Guidelines, Country Boys shall receive the following commission (collectively, the "Auctioneer's Commissions") relating to the proposed sale of the Property:

- 1. Ten percent (10%) of the first \$25,000.00 of real property sold; and
- 2. Four percent (4%) of the remaining balance of real property sold.

GENERAL INFORMATION

The Debtor is a family-owned and operated plumbing company, which was formed as a corporation on August 15, 2002 under the laws of the State of North Carolina, and which maintains a principal place of business in Fayetteville, Cumberland County, North Carolina. The Debtor provides a vast array of plumbing services to residential and commercial customers in and around Cumberland County, North Carolina.

The Debtor filed a voluntary petition seeking relief under chapter 11 of the Bankruptcy Code on January 15, 2018.

The Debtor is proposing, after notice to all creditors, to sell the Property described herein, and firmly believes that approval of the public sale is in the best interest of all creditors and parties in interest. Country Boys shall conduct the public sale of the assets as proposed herein, with all net proceeds from the sale of these assets to be distributed in accordance with any existing security instruments, the priorities of the Bankruptcy Code and future orders of the Bankruptcy Court.

Country Boys may solicit private sales of the Property, in advance of the public sale. Any offers of private sale received by the Debtor will be subject to approval of the Bankruptcy Court.

The Debtor proposes to distribute all proceeds of sale pursuant to the priority of liens upon the Property or pursuant to separate Orders of the Bankruptcy Court. It is unknown whether proceeds will be available for distribution to unsecured creditors.
